What You Should Know

Host-to-Host functionality is now available in J.P. Morgan Access®, our global cash management platform, providing visibility into Host-to-Host configuration and file processing. Listed below are answers to common questions about these Host-to-Host capabilities.

Question	What You Should Know
What Host-to-Host capabilities are available in Access?	<ul style="list-style-type: none"> • The Host-to-Host dashboard provides Access users the ability to monitor file transmissions and Host-to-Host security keys from the Access homepage. • Host-to-Host also offers an online key renewal feature that allows entitled users to renew expiring security keys online and activate them on demand. You must complete an enrollment process to take advantage of this feature.
When will I receive these Host-to-Host capabilities?	<ul style="list-style-type: none"> • Host-to-Host for Access will be activated for certain eligible clients during 2022. • If you wish to take advantage of these features, contact your Relationship Team.
Who should have access to these Host-to-Host capabilities in Access?	<ul style="list-style-type: none"> • Your Treasury and Technical teams may both benefit from these new features. Host-to-Host may be entitled separately from other Access banking products.
How do Access users get access to the Host-to-Host dashboard?	<ul style="list-style-type: none"> • An Access Security Administrator (SA) must entitle users to the Host-to-Host functions for users to see the information on the dashboard.
What if an individual is not currently an Access user but requires Host-to-Host?	<ul style="list-style-type: none"> • An Access SA may create a new Access user profile for that individual. The Host-to-Host entitlements are independent of other Access entitlements, so access to bank account data is not required.
What are the Host-to-Host entitlements in Access?	<ul style="list-style-type: none"> • Once Host-to-Host is enabled on Access, there are two entitlements that are immediately available for SAs to entitle to users: <ul style="list-style-type: none"> ○ View Key Management: Enables the user to monitor Host-to-Host security keys so that action may be taken prior to expiration. ○ Host-to-Host File Status: Enables the user to view status and detailed file delivery information. • There are two additional Host-to-Host entitlements available under Key Management for clients who are enrolled in online key renewal: <ul style="list-style-type: none"> ○ Upload: Enables the user to upload a new key to replace an expiring key, and to stage it for activation on Host-to-Host. ○ Activate: Enables a second user to authenticate and activate a staged key on Host-to-Host for on-demand availability.

How do I enroll in online key renewal?	<ul style="list-style-type: none"> • Please contact your Relationship Team to initiate the enrollment process. • You must complete and submit documentation to authorize the setup of online key renewal.
Are there special requirements for users who are entitled to online key renewal?	<ul style="list-style-type: none"> • Users who are entitled to the key renewal Upload and Activate functions require a security token. If your company uses RSA SecurID® tokens, the software token option is recommended.
